



- Coordinate with industry partners to facilitate practical training sessions, workshops, and internships.
- Conduct assessments and evaluations of student performance.

4. Responsibilities of Jay Vikas Mahavidyalaya

- Provide industry experts to deliver practical training and guest lectures.
- Offer access to industry facilities and equipment for practical sessions.
- Facilitate internships and on-the-job training opportunities for students.
- Assist in the development and periodic review of the training curriculum.
- Provide feedback on student performance and potential improvements to the programme.

5. Funding and Resources

Each party will bear its own costs and expenses related to this programme unless otherwise mutually agreed upon in writing.

6. Confidentiality

All parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the course of this programme.

7. Intellectual Property

Any intellectual property developed jointly during the training programme will be owned jointly by Shri Haridasan Mahila Mahavidyalaya, and Jay Vikas Mahavidyalaya. Any pre-existing intellectual property will remain the property of the respective party.

9. Termination
